## Captain Terry E. Magee



Graduated from Brockport with a BA, with a major in Biology and minors in Math and Chemistry, and was accepted into the Navy's aviation program.

Went to Pensacola Florida for Aviation Officer Candidate School for four months, and then through 13 months of Flight training. After graduating he began his career in an E-2 *Hawkeye* Squadron at the Naval Air Station North Island in San Diego. Over the next 27 years he accumulated over 6000 flight hours and over 1000 Carrier landings—almost half of them at night.

During his career with the Navy he went to the Navy Postgraduate School and received an MBA in Financial Management. He also had the opportunity to command four organizations:

- Commanding officer of VAW-112 an E-2C squadron of 40 officers and 250 enlisted.
- Commanding Officer of VAW-110, the E-2 Replacement Air Group Squadron, where there were 150 officers and around 700 enlisted; the mission was to train all the Pilots, Naval Flight Officers and maintenance technicians for the E-2C squadrons that manned the 12 Air Groups and 12 Carriers.
- Commanding Officer of the Amphibious Ship *Duluth* (LPD-6), which had a crew of 800, and carried a compliment of 1100 Marines.
- Commanding Officer of the Aircraft Carrier the USS *Kitty Hawk* (CV-63), which had a crew of about 5,500.

His last tour in the Navy was at the Pentagon where he was Executive Assistant to the Joint Chiefs J6 (Command, Control, Communications and Computers) and to the Chairman of the Joint Chiefs of Staff.

He retired from the Navy and went to work for a company called Veridian as a Vice President and ran their business portfolio in San Diego and Charleston, South Carolina. In 2000 he joined a small

company called Orincon as the President, and built the company up from about 17M to 75M, when it was acquired by Lockheed Martin. He stayed with Lockheed Martin for 5 years as a Vice President, and was responsible for a business unit of about \$300M for 3 years. During the last 2 years he did strategy, mergers and acquisitions at the Corporate Level for Lockheed Martin. He left Lockheed Martin to join a company called Wavestream, which made Power amplifiers for satellite communications, both for commercial and defense customers. Wavestream was owned by Venture Capitalists and his charter there was to grow the company and to sell it. After growing from about 30M to 80M it was sold to an Israeli Company called Gilat, where he stayed for one year after the acquisition. After Gilat he went to a company called Epsilon Systems Solutions for 18 months as President. After putting the infrastructure, processes, and discipline in place for Epsilon he left and has since been consulting for small companies that are looking to grow to a liquidity event, and is also on the Boards of several nonprofit organizations in the San Diego area.
