TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

KNOW YE, That Giuseppe DiMaggio

the sole owner of the oil screw or vessel called the
J. DiMaggio, Official Number 240022
of the burden of 160 gross and 80 net tons, or thereabouts, for
and in consideration of the sum of Ninety-one Thousand Four Hundred
Fifty (\$91,450.00) - - - - - dollars,
lawful money of the United States of America, and other good and valuable con-
sideration to him in hand paid, before the sealing and delivery of these
presents, by the United States of America, represented by the War Shipping
Administration, the receipt whereof he do es hereby acknowledge and
is therewith fully satisfied, contented, and paid, has s bargained and
sold, and by these presents do es bargain and sell, unto the said United
States of America, represented by the War Shipping Administration, and assigns
the whole of the said vessel, "as is",

together with all her engines, boilers, machinery, masts, bowsprit, sails,
boats, anchors, cables, tackle, furniture, and all other necessities thereunto
appertaining and belonging, including all spare parts on board and ashore,
consumable stores and bunker fuel oil aboard at the time of delivery, and
excluding leased equipment, if any

a copy of the latest CONSOLIDATED CERTIFICATE OF ENROLLMENT AND LICENSE of
said vessel is attached hereto and made a part hereof,

TO HAVE AND TO HOLD THE SAID vessel and appurtenance thereunto belonging as aforesaid, excluding leased equipment, if any, unto it the said United States of America, represented by the War Shipping Administration, and assigns, to the sole and only proper use, benefit, and behoof of it, the said United States of America, represented by the War Shipping Administration, and assigns forever: And he the said Giuseppe DiMaggio

has promised, covenanted, and agreed, and by these presents does promise, covenant, and agree, for himself, his heirs, administrators, executors, and assigns, to and with the said United States of America, represented by the War Shipping Administration, and assigns, to warrant and defend the title to and in the said vessel and all of the other before-mentioned appurtenances against all and every person and persons whomsoever, and also warrants that said vessel and appurtenances are free and clear of liens, mortgages or other encumbrances of any nature whatsoever.
